ORDER :-

In the reference G.O.1st read above, Government have constituted a Group of Ministers (GoM) to examine issues related to land allocation for various Institutions in the CRDA Region. Accordingly, the 18th Meeting of Group of Ministers (GoM) was held on 23.06.2025. After reviewing previous land allotments and considering new proposals, the Group of Ministers submitted its recommendations to the Government in the reference 4th read above.

- 2. In the reference 5th read above the Commissioner, APCRDA has submitted that, in the 50th APCRDA Authority Meeting held on 5th July 2025 vide resolution No.560/2025 has resolved that, to place the recommendations of the 18th Group of Ministers (GoM) Meeting held on 23.06.2025 before the Government for further necessary approvals.
- 3. After careful examination of the matter, the Government hereby approves the following recommendations made by the Group of Ministers concerning the review of land allocation to various institutions within the CRDA region.
